### **Health Guarantee and Health Contract**

This agreement is made, and hereby entered into, on this (date) \_\_\_\_\_ by and between **Bridgitte G. Knapp** (hereafter referred to as “**Seller**”), and (**Buyer’s name**) \_\_\_\_\_ (hereafter referred to as “**Buyer**”), for the purpose of setting forth the terms and conditions of the purpose by the buyer of a purebred.

#### **Puppy Description**

**Eyes: Left: Blue; Right: Blue;** At the time of the sell. The eye’s may change color as the pup grows older.

**♥♥ We require that your puppy visit your local veterinarian within 14 days of your purchase of the puppy. All guarantees are considered null and void if your veterinarian within this 14-day time limit does not check your puppy.♥♥**

The seller fulfills a 14-day guarantee of puppies against contagious/communicable diseases. This statement is only valid if your veterinarian checks the puppy, in office, by the fourteenth day after your puppy is picked up from Braveheart Catahoulas. The Seller guarantees your pup to be sound in mind and body. Upon a communicable or contagious disease finding, the Seller requires verification from your (the Buyer) veterinarian and verification from the Seller’s chosen veterinarian. Upon these findings, the Seller and Buyer will discuss and agree upon one of these two options:

- 1) (In the event of death from disease) Replacement of this puppy with another puppy of same sex. If there are no littermates available from this litter at that time for replacement, the new owner will accept a replacement puppy from a later litter or an adult/older pup from the Seller.
- 2) Seller will pay 20% of documented veterinarian costs for puppy’s FIRST TREATMENT of said condition, with a receipt from veterinarian’s findings.

**♥♥ Please keep in mind that all diseases of this sort have a five to ten day incubation period. Therefore, be mindful of where you take you puppy before the completion of its vaccination regime/schedule. ♥♥**

Although it is our goal to only raise hip dysplasia free dogs, we cannot guarantee your pup free from Hip Dysplasia. Please note that your veterinarian and the Orthopedic Foundation for Animals may detect this disease at age two. We recommend testing your dog at age two. If **both** Seller and Buyer's veterinarians diagnose the dog with crippling Hip Dysplasia, the Seller will provide a replacement puppy or dog after the first dog (diagnosed with HD) is neutered or spayed. Braveheart Catahoulas also requires proof of said condition and of neutering or spaying thereafter.

**Replacement does not include transportation or veterinary costs.**

Although we cannot guarantee against blindness or deafness in your puppy, this condition is very unlikely until your puppy reaches old age (7 years of age and older). If you choose to report any confirmed genetic deafness or blindness in your puppy's first year to the Seller, the Seller will provide a replacement puppy or dog provided that the condition is unrelated to the double merle gene complex. **The replacement puppy or dog will be provided after the first dog (diagnosed with blindness or deafness) is neutered or spayed.** Braveheart Catahoulas also requires proof of said condition and neutering or spaying thereafter.

**The Buyer agrees that any and all transportation costs, to and/or from the Seller's premises, will be at the cost and sole responsibility of the Buyer.**

The Buyer agrees to maintain preventative health care of the dog such as adhering to a regular immunization program, proper nutrition, proper exercise, clean fresh water, human socialization, basic obedience, and keeping the dog's kennel or living space clean, safe, and under close supervision at all times.

Ownership of the dog shall be transferred to the Buyer for the sale price of \$\_\_\_\_\_; to be paid in full on or before the dog is picked up. Only after the agreed upon amount is paid may the dog be removed from the Seller's premises.

The Buyer agrees that should it become necessary to sell or otherwise place this dog, the **Buyer will notify the Seller before taking such action so that the dog may, at the Seller's option, be repurchased by the Seller.** Upon notification, the Seller shall have fourteen working days to exercise said re-purchase option.

This agreement is made and signed by both parties for the protection and well being of this animal. If any part of this Agreement is breached, the Seller is released from any further obligations hereunder.

**Should the Seller need to seek legal action against the Buyer for violation of this Agreement, the Buyer will assume any and all attorney costs and court fees.**
